Proposed Modifications to Facilities Use Policy (CSD No. 707)

- Maintain existing fee structure as outlined in current policy (attached).
- Modify definition of groups and applicable fees as follows:
 - School Related Group No change.
 - **Booster Organization** No change.
 - <u>Non-Profit/Resident Group</u> (*Replaces "Community Related Group" classification*) – A non-profit organization that has a limit on its roster size and in which 75% or more of its members are residents of the Carlynton School District OR a non-profit organization that has no limit on its roster size and in which 50% or more of its members are residents of the Carlynton School District. (Maintain existing fee structure as outlined for "Community Related Group".)
 - <u>Non-Profit/Non-Resident Group</u> (*Replaces "Individual/Group" classification*) – A non-profit organization that does not meet the requirements outlined for "Non-Profit/Resident Group", "Booster Organization", or "School Related Group". (Maintain existing fee structure as outlined for "Individual/Group".)
 - For-Profit/Resident Group (New) a for-profit organization that is legally located within the Carlynton School District and pays earned income or real estate taxes to one of the municipalities in the Carlynton School District. (Subject to same fee structure as outlined for "Individual/Group".)
 - For-Profit/Non-Resident Group (New) a for-profit organization that does not meet the requirements outlined for "For-Profit/Resident Group". (Subject to twice the fees as outlined by the fee structure for "Individual/Group".)

• For "Non-Profit/Resident Group", assess a non-district member fee that would go directly to the school district:

- \$1 per non-district resident per event or practice, <u>OR</u>
- \$60 per non-district resident per year, <u>OR</u>
- the "Individual/Group" fee outlined by the fee structure, whichever is less.

- ** **Booster Organization** Officially recognized organizations by the Carlynton School District Board of Directors as fund raisers for a particular school activity, team, or club.
- *** School Related Any event, activity, or organization through which school-age children and/or parents/guardians of school-age children and educators employed by the District seek to advance the goals of quality education found in 22 PA CODE 5.201 and which is funded and/or sponsored, in whole or in part, by the Board of School Directors.
- **** **Community Related** An organization where 75% or more of the members of the organization are residents of the Carlynton School District.

Base rental fees do not include District expenses (custodial or maintenance fees, other personnel, supplies, use of equipment, etc.). Prior to approval District will provide applicant with exact cost.

All events are limited to five (5) hours. Any events exceeding this limit will be subject to additional fees.
