## Section I - Introduction

1. The justification for disclosing this specifically sanitised copy is as follows: **to inform the Ethics Committee of the broad reasoning for the removal of its Committee Chairman.** This justification is precise and limited to avoid unfairly incriminating other individuals affected, without offering their departments the same information.
2. The sanitisation of this document has taken place with the aforesaid specific justification in mind. **Contents have been omitted if their inclusion does not fall pursuant to the specific justification outlined above** - therefore all contents unrelated to the reasoning for the former Committee Chairman's removal have been redacted.
3. This is a **sanitised copy** of *The Mayflower Report*. This copy is authorised for disclosure to the Ethics Committee **only**. All evidentiary exhibits have been removed for the following reasons:
  - a. Some evidentiary exhibits contain sexually suggestive material, which is now forbidden as per the new no-tolerance policy towards sexual content.
  - b. Some evidentiary exhibits contain classified information and/or commercially sensitive information related to development.
  - c. The disclosure of evidentiary exhibits risks compromising sources and methods.
  - d. It is not necessary to include evidentiary exhibits, since **the O5 Council has ascertained the veracity of evidence included in the report.**
4. The following sections of the document have been redacted either for reasons detailed in item (1), or due to an absence of necessity to disclose affairs internal to the Internal Security Service and O5 Council:
  - a. Section I, items (7-10), (16) (b-e),
  - b. Section II, items (1-5),
  - c. Section III, items (4-5),
  - d. significant portions of Section IV, items (3-6),
  - e. Section V, items (6-7),
  - f. Section VI,
  - g. Section VII, items (2-7),
  - h. Exhibits 1 to 30.

5. The sixteen (16) pages of the original document have been redacted down to thirteen (13) pages.
6. “*Flowerfreak Council Oml4*”, colloquially known as “*Mayflower Compact*” (the “**Mayflower Server**”), is a Discord server hosting several members of the Ethics Committee, Department of Diplomatic Affairs, Scientific Department, Anomaly Actors, and Manufacturing Department (see [REDACTED]).

11. The **Service** concluded that the **Mayflower Server** did not require any further direct action, [REDACTED]; however, it continued to coordinate covert monitoring activities within the **Mayflower Server** due to the risk that a future problem would emerge.
12. In [REDACTED], the **Service**’s covert monitoring revealed activities of concern from several [REDACTED].
13. Accordingly, the **Service** completed an extensive investigation (the “**Investigation**”) into the **Mayflower Server**. The **Investigation** revealed to the **Service** that activities within the **Mayflower Server** posed a liability towards Pathos’ community welfare, reputation, and ethical standards.
14. As such, this report (the “**Report**”) has been authored and sent to the O5 Council (the “**Council**”) with the intention of compelling O5-5 (Overseer for the Ethics Committee) and other members of

the Council, where appropriate according to the scope of their responsibilities, to enact the crucial action outlined in Section VI.

15. The **Report** comprehensively establishes two key elements, which should be thoroughly considered by the **Council**:
  - a. the inappropriate, unethical, and reputationally compromising conduct of notable Pathos members within the **Mayflower Server** (Sections III, IV & V); and
  - b. the crucial action necessary to protect Pathos' community welfare, reputation, and ethical standards (Section VI).
  
16. The **Report** addresses the actions of the following individuals:
  - a. **Winter\_Selection**, Committee Chairman of the Ethics Committee, Actor of the Anomaly Actors, Security Cadet of the Security Department, Quality Assurance of the Manufacturing Department, and Community Officer of the Community Staff Team.

### Section III - Inappropriate Collection, Distribution, and Misuse of Personal Information

1. On July 24 2024 [REDACTED], **Winter\_Selection**, and [REDACTED] had discovered a social media account belonging to [REDACTED].
2. These individuals used this social media to find [REDACTED], purported to be [REDACTED] (see [REDACTED]).
3. **Winter\_Selection** discovered another social media account belonging to [REDACTED] and opened direct messages belonging to the account where he proceeds to make a joke (see [REDACTED]).

## Section IV - Unauthorised Disclosure of Explicitly Classified Material

1. The Service Entry Assessment was explicitly classified SC4 as per its cover page markings (see [REDACTED]). On June 20 2024 **Winter\_Selection** posted a picture of the **Service's** Service Entry Assessment in the **Mayflower Server** (see [REDACTED]). The **Mayflower Server** contains individuals who do not qualify to view the SC4 material, as per the special access groups detailed in the original announcement (see [REDACTED]). This therefore constitutes an SC4 information breach.
2. Furthermore, **Winter\_Selection** shared an image from the Anomaly Actors Discord server (see [REDACTED]). This constitutes an SC5 information breach.

## Section V - Sexually Suggestive, Inappropriate, and Vulgar Behaviour

1. On July 24 2024 [REDACTED] posted an image in the **Mayflower Server** from a Roblox tycoon game they played with **Winter\_Selection**.
2. This image contained vulgar and sexually suggestive comments made by **Winter\_Selection** (see [REDACTED] & [REDACTED]).
3. Further behaviour was exhibited in a second Roblox game played by **Winter\_Selection**, [REDACTED], and [REDACTED] displaying sexually imitative behaviour with **Winter\_Selection** glorifying rape (see [REDACTED] & [REDACTED]).
4. [REDACTED] shows **Winter\_Selection** utilising the “*Nurmonic*” server bot in the **Mayflower Server** in a sexually suggestive manner.
5. The “*Nurmonic*” bot is designed to “*adapt to your server's vibe, engage in conversations, and add dynamism to your community*” (see [REDACTED]). [REDACTED] shows the “*Nurmonic*” server bot responding in a sexually suggestive manner. This demonstrably proves that the “*Nurmonic*” bot was manipulated to adopt a sexually suggestive tone in the **Mayflower Server**.

## Section VII - Recommended Course of Action

1. **Winter\_Selection** must be removed from his position as Committee Chairman and issued with a Foundation blacklist for the following reasons:

- a. **Winter\_Selection** engaged in conduct which risks a scandalous public image and jeopardises Pathos' reputation.
- b. **Winter\_Selection** engaged in the unauthorised disclosure of material explicitly classified Security Class 4.
- c. **Winter\_Selection** engaged in sexually suggestive, inappropriate, and vulgar conversations which undermine community welfare.
