It's been a busy year of progress and promise at Solar Cookers International. In January, the 6th SCI World Conference was held in Gujarat, India, with over 200 participants from 30 countries in attendance. Throughout the summer, SCI staff continued collecting data on the worldwide adoption rates of solar cooking, developing the "SCI Performance Evaluation Protocol (PEP) for Testing and Reporting Solar Cooker Performance", and launching pilot solar cooker testing centers in California, New York, and Nepal. In November, SCI represented the solar cooking sector at the UN Climate Change Conference (known as COP 23) in Bonn, Germany. Soon, SCI will unveil the 2018-2020 Strategic Plan and will continue building a global movement for solar cooking advocacy.

Those are just a few of the annual highlights at SCI... but we would like to hear from you, our supporters.
